- 3 It must be ensured that "Quarterly Performance Report (QPR)" in the enclosed format is submitted to this office, duly countersigned by the inspecting official of M/s RITES/Consignee (in case of consignee inspection only), regularly without fail for the supplies made during the period of approval and a declaration that the supply position shown in the "QPR" is exclusive list of supply of material duly inspected by RITES/Consignee and no other material got tested/inspected by RITES/Consignee & supplied to the Railways including OHE & TSS contractors and no failure reported from any Zonal Railway during the period of approval underneath the "QPR" itself. In case of "Nil" supply and non participation in any tender during the period of approval, this office should be appraised of the reasons thereof.
- 4 Please ensure that the details of your internal check/testing and RITES inspection/test certificates for the supplies made by you are maintained properly in a bound register separately, duly signed by inspecting official.
- 5 Notwithstanding, what has been stated above, this office reserves the right to cancel your approval or delete your name from the list of approved suppliers at any time without notice or without assigning any reasons thereto. For further renewal, if any desired by you, it will be your responsibility to apply at least **three months** prior to the date of expiry of this approval, along with details/ documents as mentioned in Clause 6.2 of Guidelines for general procedure for enlistment of firms as CORE approved manufacturer for Electrical items available on CORE's Website www.core.indianrailways.gov.in. Renewal shall be dealt as per Clause-6 of aforesaid Guidelines.
- 6 Your firm is subject to periodical inspections at different manufacturing stages by Railway's authorized representative for general assessment and testing of components for ensuring quality. You are required to provide adequate facilities for inspection and testing of above items at your works.
- 7 You shall follow the provision of Quality Assurance Scheme issued by CORE/RDSO and relevant BIS Codes and maintain complete records of manufacturing and testing etc. done internally by you as well as those by inspecting authorities.
